

## **Water Test Judges**

**Dates:** Open date for entries is Monday July 18, 2011. Postmarks before this date will be returned. Closing date for entries is Monday September 5, 2011.

**Entry Limit:** 20 in both junior and senior divisions combined. Entries over the limit will be placed on a list of alternates.

**Post-entries:** Dogs earning titles in junior division **may** post-enter senior division on the day the title is earned.

**Re-qualifiers** will be accepted as space allows and will be judged last in their class.

**Dogs with WRDs** may enter either or both junior and/or senior division at each test. However, re-qualifiers in junior division may not compete in senior division unless they have pre-entered, i.e., they **may not** postenter.

**Bitches in season** may compete but will be judged after all other entries (including post-entries) have been judged.

**Entry Fee:** First entry \$40.00, \$30 second entry and post-entries. All fees are payable to the Newfoundland Club of San Diego or NCSD.

**Water test regulations**: All entrants are responsible for reading and understanding the NCA Water Test rules and regulations.

**Description of site**: Glorietta Bay is a salt-water site. There is ample green grass and trees for shade. If you have a tent or shade, it is a good idea to bring it. The beach is clean and the water is typically very clear. There is a moderately quick drop off. Most dogs will be swimming within 10 feet. Ample parking is usually available. There is no fee to park.

**Pre-test practice:** The site will be available for informal practice on Saturday September 17, 2011 from 1:00 pm to 3:00pm.
