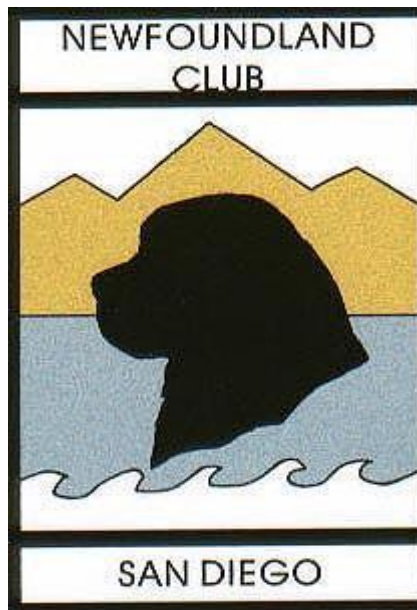

**Dates:** Entries postmarked prior to August 11, 2014 will be returned.

Closing date for entries is September 17, 2014 by 6:00 pm. If you send entries via next day mail, please sign the "Waiver of Signature" space.

**Entry Limit:** The Water Test is limited to 20 entries with a minimum of 2 entries in WRDX and a minimum of 3 entries in WD and WRD combined. The first 20 entries that arrive or are pulled in a lottery would get into the test regardless of their division.

Entries over the limit will be placed on an alternate list. Openings will be filled from the alternate lists in the order received. If entries exceed the entry limit, a lottery will be conducted.

**Re-qualifiers:** Re-qualifiers will be accepted as space allows. In other words, untitled dogs will be given first priority even if their entry is received after that of a titled dog. Re-qualifiers in Junior Division MAY NOT post-enter Senior Division. However, new titlists in Junior Division MAY post-enter Senior Division. Dogs may be entered in more than one division on the same day but only if they have already qualified at previous tests in all of the divisions entered. If the entry for the test exceeds its limit and a lottery is necessary, the dog may not get into each division entered. There will be no substitutions for dogs to change divisions if their entry is chosen for one division but not the other in a lottery. Judges must excuse any dog not in condition to finish the division entered and, if so, the dog will not be able to continue in any other division entered that day. Entry fees will not be refunded for dogs that are excused. Entrants are discouraged from pushing their dogs beyond their limits.

**Entry Fee:** First entry \$40 per entry, \$30.00 second entry and post-entries (of same dog). For example, for dogs re-qualifying in **both** junior and senior divisions on the same day, the entry fee is \$70.00. Please make checks payable to the Newfoundland Club of San Diego or NCSD.

**Required Forms:** The Newfoundland Club of America requires a photocopy of each dog's AKC, ILP/PAL, or foreign registration paper with each entry.

**Water Test Regulations:** These tests are conducted in accordance with the NCA Water Test Regulations effective January 1, 1999 and updated February 2012. Exhibitors are responsible for reading and understanding the regulations in their entirety. Test Regulations are available at a cost of \$5.00 per copy from the NCA Working Dog Committee Publications Contact, Dwight Gorsuch, at 6282 Burris Road; Rock Hall, MD 21661-1100. **Description of the Test Site:** Glorietta Bay is a saltwater site. There is ample green grass and trees for shade. If you have a tent or shade, it is a good idea to bring it. The test site is occasionally windy in the afternoon. The beach is clean and the water is typically very clear. There is a moderately quick drop off. Most dogs will be swimming within ten feet. Ample parking is usually available. There is no fee to park. This is a public park and dogs being tested are allowed with special permission. Therefore, only entered dogs are allowed and must be leashed or crated while not testing. Thank you for your understanding.

**Pre-Test Practice:** There will be no pre-test practice at the test site.

**Miscellaneous:** Bitches in season will be allowed to participate, but will be judged after all other entries have completed the entire test.

## **Agreement**
